

Passport to an Amazing Childhood Mission Competition

Terms, Conditions and Waiver(s) Document (Warning: This is a legal Document that Affects Your Rights) Nature Play Queensland is a program of Queensland Outdoor Recreation Federation Inc. (QORF)

By clicking the 'I agree to the terms, conditions and waiver(s)' you may enter the competition and you are agreeing to the following statement:

I acknowledge, understand, accept and agree:

1. All people (children and adults) who participate (referred to as *participant[s]* from hereon) in the Nature Play Queensland 'Passport to an Amazing Childhood Mission Competition' (referred to as *[the] competition* from hereon) do so of their own free will;
2. Minors (<18 years old) have received consent to participate in *the competition* from one of their legal guardians, who is 18 years of age or older and who is authorised to do so (referred to as *[the] guardian* from hereon) and who understands the risks associated with outdoor play and posting or submitting images (of minors) on social media;
3. There are risks of injury, disability and death associated with participating in *the competition*, in addition to significant benefits that *the competition* may provide; accordingly, I (with the necessary authority) release all persons or organisations associated directly or indirectly with the conduct of *the competition* from all claims, demands and proceedings arising out of the participation by *the participants* and hereby indemnify these persons and organisations against all liability (including liability for their negligence and the negligence of others) for all injury, loss or damage arising out of or connected with the participation of *the participants* of the *competition*;
4. This release and indemnity (as at point 3) shall extend to and include the Queensland Outdoor Recreation Federation Inc, Nature Play Queensland (referred to as *the organisers* from hereon), their respective committee members, partners, managers, officers, agents, contractors, employees and volunteers, including the owners, licensees, occupiers of the land upon which *the competition* or any part is conducted, (representatives of) any statutory body or local authority having control over any land upon which *the competition* or any part of it is conducted or which is involved directly or indirectly with *the competition* in any manner whatsoever;
5. This release and indemnity (points 3 and 4) continue forever and binds the *participants* of *the competition*, their heirs, executors, personal representatives and assigns;
6. A single entry is counted and classified as one unique (1) mission, which is a recorded photo or video, written, audio or drawn account of the mission, submitted via the online form;
7. Referring to point 6, legal guardians, or adults who are authorised by the children's legal guardians to do so, can submit an unlimited number of entries to *the competition* over the submission period;
8. All submitted missions and associated works and ideas become the legal property of the *organiser of the competition*;
9. The submission period is from 27th November 2020 to 14th December 2020;
10. After the submission period has ended, all entries will be judged by the *organiser's* selection panel to determine the winners of *the competition*;
11. The *prize* winner(s) of *the competition* is / are, the person(s) who provided the mission(s) selected for publication in the new Nature Play QLD Passport to an Amazing Childhood, Queensland edition;
12. The *prize* is the publication of a winning submission (or part or form thereof) in the new Passport to an Amazing Childhood, Queensland edition. An alternative prize may be selected and provided

by *the organiser* in case this new Passport to an Amazing Childhood is, for whatever reason, not published;

13. All submissions may be used and published by *the organiser*, refer to point 8;
14. The *organiser* of the *competition* has the right to cancel, postpone or cease any or all aspects of *the competition* and its prizes.
15. My email address and / or phone number will be used to communicate information regarding the *competition* and that my email address is added to Nature Play Queensland's e-newsletter subscribers list. I can opt out of this free subscription via the link provided in this newsletter.
16. That I grant the right regarding (or have the consent and authority to do so) all *participants* I have entered into *the competition*, to be photographed, filmed and / or interviewed on behalf of, or with the explicit consent from, *the organiser* and that this resulting *footage* may be reproduced and / or used by the organiser or authorised third parties, including media outlet(s) for, for example, reporting, promotional and advertising purposes. This (also) means that the footage may be:
 - a. Used in (with *the organiser's* consent) - including, but not limited to - printed and electronic form in different forms of publication including printed materials, websites, social media, digital (including live) streaming, television, radio, websites, social media etc.
 - b. Retained and stored in hard copy or digitally.
17. That the rights granted to *the organiser* at 16, 16a and 16b are perpetual and that I will not receive any payment, royalty or other consideration (whether monetary or otherwise) from the organiser for the making, use or storage of this footage;
18. The *footage* of all *participants*, expressly or by implication, at the time of production and publication, a. to the best of *the organiser's* knowledge, is true and correct, is made in good faith and b. is not intended to defame, offend or bring any of *the participants* into disrepute.
19. The *organiser* is the owner of the copyright in the footage;

20. I am 18+ years of age and I am the legal guardian or have the appropriate authorisation from a legal guardian for / of *participants* I may submit entries for who are aged younger than 18 years old.
